

Participant Assumption of Risk, Waiver, Release, Indemnification of All Claims & Covenant Not to Sue

By signing this agreement, you give up your right to bring a court action to recover compensation or obtain any other remedy for any personal injury or property damage however caused arising out of your participation in/at Bethany Bible Camp, now or at any time in the future.

Acknowledgment of Risk

I, as legal guardian of the participant identified below, hereby acknowledge and agree that participation in Bethany Bible Camp activities comes with inherent risks. I have full knowledge and understanding of the inherent risks associated with Bethany Bible Camp participation, including but in no way limited to: (1) slips, trips, and falls, (2) aquatic injuries, (3) athletic injuries, and (4) illness, including exposure to and infection with viruses or bacteria. I further acknowledge that the preceding list is not inclusive of all possible risks associated with Bethany Bible Camp participation and that said list in no way limits the operation of this Agreement.

Coronavirus / COVID-19 Warning & Disclaimer

Coronavirus, COVID-19 is an **extremely contagious** virus that spreads easily through person-to-person contact. - (4) Been in direct contact with or the immediate vicinity of any person known to be carrying the Coronavirus or who has been identified as a potential carrier of the Coronavirus.

Waiver, Release, Indemnification & Covenant Not to Sue

In consideration of the participant’s participation in Bethany Bible Camp, I, _____, the undersigned the legal guardian of the participant, agree to release and on behalf of the participant, and the participant’s heirs, representatives, executors, administrators, and assigns, **HEREBY DO RELEASE** Bethany Bible Camp, its officers, directors, employees, volunteers, agents, representatives and insurers (“Releasees”) from any causes of action, claims, or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which the participant or the participant’s heirs, representatives, executors, administrators and assigns may have, now or in the future, against Bethany Bible Camp on account of personal injury, property damage, death or accident of any kind, arising out of or in any way related to the use of Bethany Bible Camp facilities/equipment or participation in Bethany Bible Camp programs whether that participation is supervised or unsupervised, however the injury or damage occurs, including, but not limited to the negligence of Releasees.

In consideration of the participant’s participation in Bethany Bible Camp, I, the undersigned legal guardian on behalf of the participant, agree to **INDEMNIFY AND HOLD HARMLESS** Releasees from any and all causes of action, claims, demands, losses, or costs of any nature whatsoever arising out of or in any way related to my Bethany Bible Camp participation.

I hereby certify that I have full knowledge of the nature and extent of the risks inherent in Bethany Bible Camp participation and COVID-19, have explained those risks to the participant, and that I, as legal guardian of the participant, am voluntarily assuming those risks. I understand that I will be solely responsible for any loss or damage, including personal injury, property damage, or death, the participant sustains while participating in Bethany Bible Camp and that by signing this agreement I **HEREBY RELEASE** Releasees from all liability for such loss, damage, or death. I further certify that the participant is in good health and has no conditions or impairments which would preclude the participants safe participation in Bethany Bible Camp.
